## INTRODUCTION

Zero-Carbon-Ready Building Certification Scheme (hereinafter named as "the Scheme"), owned and operated by Hong Kong Green Building Council (HKGBC), aims to recognise buildings that have achieved high energy efficiency standards or reduction targets. The targets are made reference to the requirement for achieving near zero emissions by 2050 and the best performers in the building industry.

## ENERGY ASSESSOR-ZCRB (EA-ZCRB) TRAINING

This Training is targeted for professional practitioners who involve in Zero-Carbon-Ready Building Certification process.

## PRE-QUALIFICATION REQUIREMENT

The registered Energy Assessor-ZCRB should be a Registered Energy Assessor (REA) under the Buildings Energy Efficiency Ordinance (Cap.610) and taken a training course and passed an examination organised by HKGBC.

Upon completion of the Training, practitioners should have the ability and knowledge to:

- Fully understand the process of the **Zero-Carbon-Ready Building Certification Scheme (the ZCRBC Scheme)** and give professional advice to the building owner/ applicant
- Provide a detailed and independent assessment and verification services of the building's energy systems based on the building's data and information
- Use the building data to carry out the performance assessment of the building
- Fully understand the use of the web tool and the energy performance calculator
- Carry out the application of the Scheme

Candidates who completed the training, passed the examination and fulfilled the pre-qualification requirements are eligible to register as Energy Assessor-ZCRB under the Energy Assessor Registration Scheme.
