This has been an incredible week, as we join our network in advocating for a sustainable built environment to world leaders gathered here in Dubai, for the UN Climate Change Conference COP28.

This COP is a tremendous opportunity for policymakers to kickstart a decade of action to secure a sustainable future and we have seized the opportunity to raise the built environment as part of the climate solution right to the top of the political agenda.

### How are we achieving this?

- On 4 December we launched a bold, new paper called '[Social Impact across the Built Environment](#)'.

**Building and construction sector show collective force at COP28 as over 350 industry leaders sign Open Letter to**

## **negotiators and heads of states demanding the regulatory change needed to tackle the #climatecrisis**

We have joined together with our global network of Green Building Councils, Net Zero Carbon Building Commitment Signatories, partners and other supporters to present an [Open Letter](#) to political leaders and policymakers at COP28.

We insist all governments uphold their commitment to keep global temperature rise to 1.5°C and leverage the built environment as a critical climate solution by joining the [Buildings Breakthrough](#). The Open Letter, which was presented on 6 December during the 'Multilevel Action Urbanization and Built Environment/Transport' day at COP28, is accompanied by a [policy briefing](#) that lays out the regulatory outcomes urgently needed to scale up action and deliver on the sector's huge potential.

Through this joint action, we aim to demonstrate the critical role of the built environment in tackling global heating, champion the activity being implemented by our network, and provide a call to action for policymakers to step up and deliver the regulatory change the world needs.


### **An evening with our global network in Dubai, made possible by CDL**

Why do we measure and account for carbon emissions through Scopes, considering '1', '2' and '3' – but we don't consider the social impacts of the built environment upon people in the same way?

On 4 December 2023, we launched an influential and timely new publication developed by our global #BetterPlacesForPeople programme called '[Social Impact across the Built Environment](#)'. The position paper is supported by the UN High-Level Climate Champions (HLCCs) and provides a framework for the building and construction sector to define, measure and take action on social impact to support an equitable and decarbonised built environment.


